## NHBA-KUNSTFEST 2019

### Rules of the Festival

Pre-registration with a Kunstfest Committee Member is required to comply with town ordinances. Must be registered by July 1, 2019 to be on the Kunstfest Map. Vendors must leave assigned areas as clean as found.

Historical craftsmen are exempt from fees and may sell their crafts providing they meet the following criteria:

1. Vendor demonstrates for the purpose of education a historical craft.
2. Vendor and helpers dress in period or pioneer costumes.
3. Only crafts demonstrated can be sold from fee exempt booths.

NHBA-KUNSTFEST 2019 is not liable for loss, damage or injury to vendor or vendor property.

By entering into this agreement and signing the registration form NHBA-KUNSTFEST 2019 committee members are released from liability arising out of the NHBA-KUNSTFEST 2019 event.

**Vendors must check in, BEFORE SET-UP, at the information booth located at Church and Main Streets.** Vendors set up in the wrong space will be required to move. Any vendor without a permit will be in violation of town ordinances & asked to pay for permit or vacate the premises.

**No refunds;** funds are immediately spent on advertising the event.

Posey Co. Temporary Food Permit required for all food vendors in accordance with Indiana State Law.
