Rules of the Festival

The festival will be held rain or shine in the historic district on Main Street between Church and North Streets and along Granary between Main and West Streets. Indoor booths will be available at the Granary.

Pre-registration with an Arts in Harmony committee member is required to comply with town ordinances. Must be registered by April 1st to be included on festival map.

Only vendors selling their own ORIGINAL works will be eligible to participate. No kits, dealers, or agents will be permitted. The Arts in Harmony committee will make all decisions for acceptance of participating vendors.

All outdoor exhibitors are required to provide a 10 X 10 tent for display. No exceptions. Indoor exhibitors will have approximately 10 X 10 display area.

Food vendors are required to provide their own setup and proof of insurance, and will be located on Main Street from Church to North Street. Posey Co. Temporary Food Permit required for all food vendors in accordance with Indiana State Law.

Artists and authors must represent their own work during the show. Artwork must be original. No resellers will be accepted. Any vendor that attempts to resell will be asked to remove these items. All vendors will handle their own sales.

Demonstrations of art or craft are welcome during the event.

The committee reserves the right to view each booth after setup and request that any work not up to standard be removed.

Vendors must check in **before set up** at the information booth located at Church and Main Streets. Set up will begin at 4 pm on Friday, May 31st.

No breakdown of display will be permitted before 4 pm on Sunday without the express permission of the Festival chair, Tony Treadway.

General Security will be provided from 7 pm on Friday until 4 pm on Sunday.

ATM's available at both gas stations, The Yellow Tavern, and at Heritage Federal Credit Union.

No Pets or Golf Carts will be allowed on the Streets of the Festival, this is a safety issue.
